The undersigned hereby makes application to Hohokam Irrigation & Drainage District for electrical service. In consideration of Hohokam's providing electrical service as herein applied for, the undersigned agrees to promptly pay for such service at the regular published rates of Hohokam and in accordance with applicable rules and regulations adopted by the Board of Directors of Hohokam; these rates are a part of this agreement whether effective at the time or subsequent to the execution of this agreement. The undersigned agrees to use such services for his/her/their own purposes and agrees not to sell or donate any part of same or permit it to be used for any other purpose. The undersigned further agrees that the duly authorized agents and employees of Hohokam shall have access to his/her/their premises to which electrical service is provided at all reasonable hours for the purposes of installation or removal of meters and equipment incidental to carrying out the purposes of this agreement and for the inspection of any electrical line or equipment in any way connected therewith. The undersigned further agrees to indemnify and hold Hohokam harmless from claims, injuries, damage and expense of every nature and kind, for loss or damage to property or persons rising out of the delivery of service beyond the point of metering or the failure of Hohokam to supply electrical service. The undersigned agrees to immediately give Hohokam written notice when he/she/they cease to occupy the premises and/or desires service to be discontinued and agrees to pay for such service until said notice is received by Hohokam. The undersigned agrees that Hohokam or its representatives may immediately and without notice to the undersigned, discontinue service in the event of failure on the part of the undersigned or his/her/their agents to comply with the provisions of this Agreement. The undersigned for and on his/her/their behalf, hereby forever release Hohokam, its agents and employees, and with respect to anyone in or about the served premises affected by such termination of service, agrees to indemnify and hold Hohokam harmless from any and all claims, injuries, damages and expenses of every nature and kind, which may arise out of or in any way connected with such termination of service. It is understood that such discontinuation of service shall not constitute a waiver by Hohokam of any rights or claims which it may have against the undersigned as a result of having provided electrical service to the undersigned. The undersigned agree that in the event that his/hers/their account becomes delinquent and is submitted for collections by the district, a 35% collection fee will be charged to the outstanding balance on the account. In the event it becomes necessary for Hohokam to employ counsel to enforce any provision of the Agreement or the breach thereof, then, in that event, the undersigned agrees to pay Hohokam all costs and expenses including reasonable attorney's fees, incurred by Hohokam whether or not litigation is commenced. (No additional contract required) "The undersigned, by voluntarily giving cell phone and wire line phone numbers, warrants the phone numbers are not the numbers of a family member or a third-party who are not named on the undersigned's account, and agrees and expressly consents (as required under the Telephone Consumer Protection Act -"TCPA") to their use for any and all communications designated and defined under the TCPA as communications requiring consent."

No service account will be initiated or transferred into a new customer's name until this application is submitted in a complete manner and all applicable security deposits are made.
